Introduction

This booklet identifies the majority of the Members of Parliament who have represented an area including Pangbourne and Purley in Berkshire. The two villages have always had the same parliamentary representation despite one being the eastern extremity of the constituency and the other the western extremity at various times.

Initially the Parliament was called for a specific purpose, usually to grant money to the King, It met where the King's court happened to be for a period ranging from a day or two to several months and then dispersed.

In the list the date the Parliament was called is given and the place it was held until it found a permanent home at Westminster.

At the end are the names of Members of the European Parliament in the period when British Members were elected to serve a constituency.

The first Council was called in 1213 and the Sheriff of each county was ordered to send four knights to represent the county.
